

In fiscal year 2016, the Ms. Foundation

- Elevated the national discussion about the devastating impact of child sexual abuse on girls, with the release of the **Sexual Abuse to Prison Pipeline** report. Created in partnership with Human Rights Project for Girls and the Georgetown Law Center on Poverty and Inequality, the report details how systemic violence and abuse place girls at higher risk of landing in the criminal justice system, which offers few resources to address deep-seated trauma.
- Doubled down on our commitment to improving women's economic security. As one of the leading women's foundations for **Prosperity Together**, we are partnering with 43 other women's funds nationwide in a bold financial initiative investing \$100 million over five years to increase women's economic equity, particularly for women and girls of color.
- Helped fund the critical and successful efforts of Raising Women's Voices to safeguard New York state women's access to **reproductive healthcare services guaranteed under the Affordable Care Act**, as they worked with legislation to ensure insurers complied with coverage guidelines in order to offer programs in the state.

Our accomplishments are not ours alone. Our strides and our successes are possible thanks to the investments of individuals and organizations that share a vision of a true democracy, in which the worth and dignity of every person are valued. The Ms. Foundation is indebted to activists and donors, from the grassroots to the grass tops, whose fierce feminism is changing lives and laws.

ECONOMIC JUSTICE: Securing Women's Opportunities & Future

As more women participate in the U.S. labor force, racial and gender bias negatively impact women's ability to earn a living wage and gain more economic opportunities. Women are the primary earners in four out of 10 households and remain primary caretakers for children, yet women represent more than 60% of the minimum wage workforce and overall earn less than men for the same work. Women make up the country's largest voting block and women of color are the fastest-growing population segment, yet policies and legislation rarely accommodate women's issues, continuing to reflect sexist, racist legacies that undervalue care responsibilities as "women's work."

The Ms. Foundation for Women's Economic Justice program promotes organized, grassroots-based efforts to address challenges women face to greater economic security. Our grantmaking strategy advances universal access to quality, affordable childcare to alleviate the burdens that working women face; raising the value and quality of jobs for childcare workers; and increasing the collective economic and political power of women in the U.S. South – a region with significant political influence.

Increasing Universal Access and Opportunities to Childcare for Low-Income Women

In 2016 our Economic Justice program continued to invest in state and local childcare advocacy groups, low-wage worker centers, and childcare provider networks to align multiple advocacy strategies advancing universal childcare access.

Within this focus, we support the work of our grantee-partners at the intersections of childcare and labor rights, building an integrated movement to address workplace issues, transform public policy on childcare subsidy access, and improve job quality for childcare providers. The resulting new understanding and analysis around the nexus of these components have made significant impact on how these various components are linked and framed by sector stakeholders, developing the leadership capacity of childcare workers and low-income parents while advancing jobs in the care sector.

Southern Strategy: Centering Women's Economic, Social, and Political Power in a Challenging Political Landscape

The South continues to be critically important to America's political, cultural, and economic landscape. The Ms. Foundation's investment in building women's power in the South – economic, social, and political – advances women's leadership as crucial to improving economic conditions for communities throughout the region. We leverage both the momentum of public opinion and perspectives on women's safety, health, and economic security, and the bold work of grantee-partners in Southern states, to advance and build a bolder, more inclusive economic justice movement.

In 2015, the Ms. Foundation invested in grantee-partner Mississippi Low-Income Child Care Initiative and their development of a Women's Economic Agenda - Making Mississippi Women Secure - in Mississippi, focusing on higher earning jobs for women, affordable access to education and childcare, and other issues that impact working women and women who want to work. During 2016, the Economic Justice program deepened its understanding of Women's Economic Agendas across the nation, with a focus on replicating ways in which grassroots platforms informed by women can be built in other cities and states. Learnings from this exploratory work by the Economic Justice program will inform Women's Safety and Health and aid in developing a cross-issue focus in the South.



Advancing Universal Access & Opportunities in Childcare

Adhikaar for Human Rights and Social Justice.....\$50,000

Executive Director: Luna Ranjit, Woodside, NY

Adhikaar for Human Rights and Social Justice, a womenled organization, promotes human rights and social justice for Nepali-speaking women and South Asian immigrants working in the informal sector as childcare providers, domestic workers, and nail salon technicians. Ms. Foundation's grant supports the continuation of Adhikaar's Quality Childcare for Economic Security project, which aims to create a new paradigm supporting low-income parents and childcare providers.

African Communities United......\$40,000

Executive Director: Amaha Kassa, Bronx, NY

African Communities Together (ACT) is a mutual aid, organizing, and civil rights organization for African immigrants and their families. Ms. Foundation's grant supports ACT's LivelyUP program, which empowers low-income African immigrant women, especially hair braiders and childcare providers, to achieve economic security.

All Our Kin \$45,000

Executive Director: Jessica Sager, New Haven, CT

All Our Kin (AOK) trains and supports childcare providers to build quality, sustainable childcare businesses. Ms. Foundation's grant supports AOK's efforts to preserve funding for Connecticut's Care 4 Kids childcare subsidy program; and advocacy on behalf of childcare providers in local communities and at the state level so they have the chance to inform and shape policies that improve job quality, service, and recognition of their contributions.

California Child Care Resource and Referral Network, Parent Voices \$50,000

Statewide Organizer: Mary Ignatius, San Francisco, CA

Parent Voices (PV) is a parent-led, parent-run grassroots advocacy project fighting to make quality childcare accessible and affordable for all families. Ms. Foundation's grant supports PV's continued efforts to increase access to affordable childcare for working families; advocate legislation and appropriations; and train low-income women as leaders and organizers in campaigns and policy building.

Center for Frontline Retail \$20,000

Executive Director: Anika Campbell, New York, NY

The Center for Frontline Retail (CFR) is dedicated to achieving quality employment in the retail sector through services, education, advocacy, and civic leadership. Ms. Foundation's grant supports CFR's Just Hours campaign, which highlights the practice of erratic and unpredictable scheduling among retailers, and advocacy for the expansion of childcare subsidies for working families in the retail industry.

Centro de los Derechos del Migrante, Inc..... \$25,000

Executive Director: Rachel Micah-Jones, Baltimore, MD/Mexico City, MX

Centro de los Derechos del Migrante (Center for Migrant Rights) is the first transnational workers' rights law center based in Mexico that focuses on U.S. workplace rights. Ms. Foundation's grant supports CDM as it strengthens and expands labor protections for migrant childcare workers, particularly those working under J-1 visas.

Childspace Day Care Centers, Inc. \$50,000

Chief Operating Officer: Susan A. Kavchok, Philadelphia, PA

Childspace Day Care Centers works to improve the quality of jobs for traditionally low-paid childcare workers, increase resources, and improve the quality of care. Ms. Foundation's grant supports Childspace as it further develops worker-owned childcare cooperatives; and its Provider Committee, comprised of women of color, which trains providers in advocacy for high quality childcare programs in Pennsylvania.

Garment Worker Center\$50,000

Director: Marissa Nuncio, Los Angeles, CA

The Garment Worker Center (GWC), a worker rights organization, organizes low-wage garment workers in Los Angeles to fight for social and economic justice. Ms. Foundation's grant supports the advancement of efforts to increase access to quality childcare services through advocacy, developing statewide alliances, and education about services available.

Mississippi Low-Income

Child Care Initiative\$50,000

Executive Director: Carol Burnett, Biloxi, MS

Mississippi Low-Income Child Care Initiative (MLICCI) is a statewide, grassroots organization of childcare providers, parents, and community leaders. Ms. Foundation's grant supports MLICCI's efforts to promote universal childcare access in Mississippi, by advocating for policy reforms that eliminate requirements for single working parents; strengthening the financial viability of childcare providers; and promoting racial equity in childcare subsidy programs.

Mujeres Unidas y Activas \$50,000

Co-Director: Andrea Lee, San Francisco, CA

Mujeres Unidas y Activas (MUA) is a Latina-founded and -led grassroots organization that promotes personal transformation and building community power for social and economic justice. MUA was instrumental in passing the historic California Domestic Workers Bill of Rights. Ms. Foundation's grant supports MUA's efforts to eliminate the sunset provision on the Bill of Rights to ensure permanent protection of domestic workers, as well as their continued advocacy on behalf of domestic workers and their families.

The OLÉ Education Fund......\$25,000

Executive Director: Matthew Henderson, Albuquerque, NM

The OLÉ Education Fund (OLÉ) is a grassroots community organization comprised of working families in New Mexico. Ms. Foundation's grant supports OLE's efforts to engage childcare workers in more direct action on childcare policies through training, education, and advocacy, and to increase funding and support for childcare subsidies and access.

Restaurant Opportunities Centers United \$15,000

Co-Director: Saru Jayaraman, New York, NY

Restaurant Opportunities Centers United (ROC United) is a national organization committed to organizing restaurant workers, conducting national research on the restaurant industry, and advocating on the national level to improve restaurant working conditions. Ms. Foundation's grant supports ROC United's actions based on its 2015 childcare initial needs assessment for restaurant workers, especially work around its assessment of non-traditional-hours care needs, including a convening in partnership with the foundation to further explore needs, access to childcare, and related issues.

Building a New Economy - Centering Women's Economic, Social, and Political Power in the South

Blueprint NC \$55,000

Executive Director: Erin Dale Byrd, Raleigh, NC

Blueprint NC (BPNC) is a partnership of state-level public policy, advocacy, and grassroots organizing groups dedicated to achieving a better, fairer, healthier North Carolina through the development of an integrated communications, civic engagement, and policy strategy. BPNC works in direct partnership with the North Carolina Black Women's Roundtable, and co-convened with Spirithouse to provide a network and safe space for black women to convene, identify, and address the unique barriers black women face regarding economic security, health, and reproductive justice. Ms. Foundation's grant supports BPNC's efforts to increase its membership list, host additional community listening sessions, and implement a communications strategy to support policies that provide safety and opportunity for Black women and their families.

Miami Workers Center \$55,0

Executive Director: Marcia Olivo, Miami, FL

Miami Workers Center (MWC) is Miami's leading social change nonprofit organization advocating for social, racial, economic, and gender justice. Ms. Foundation's grant supports MWC's coalition with New Florida Majority and other organizations representing women, women of color, workers, and community groups to advance economic security and gender justice for low-income women of color and their communities, under the FEMME Agenda program; and to create, advance, and advocate for a Women's Economic Agenda for Florida.

Making Mississippi Women Secure \$30,000

Co-Founder & Director: Cassandra Overton-Welchin, Biloxi, MS

In 2014 the Mississippi Low-Income Child Care Initiative (MLICCI) launched the Mississippi Women's Economic Security Initiative (MWESI) to holistically address barriers to women's economic success. Ms. Foundation's grant supports MLICCI's efforts to develop a strategy for a women's economic security platform in Mississippi and to reinstate the Women's Legislative Caucus in the Mississippi state legislature.



Spotlight on: Mississippi Low-Income Child Care Initiative

The Ms. Foundation for Women's Southern Strategy focuses on women living in southern states, and our work with Southern-based grantee-partners as they raise the voices and power of women at local and state levels. We were proud to support our grantee-partner Mississippi Low-Income Child Care Initiative, in their work to launch the historic Making Mississippi Women Secure Summit in October 2015. The summit, developed from MLICCI's statewide townhall tour, brought together over 500 participants from across the state; partnered MLICCI with 35 cohorts that included Planned Parenthood and the ACLU; and featured guest speaker Professor Anita Hill of Brandeis University to discuss and implement strategies that will create more economic opportunities and security for Mississippi's women.

Ms. Foundation's Reproductive Justice Program is designed to achieve equity in access to abortion, contraception, and the full range of reproductive health services for all women.

The Hyde Amendment turned 40 in 2016. The amendment continues to prevent low-income women from accessing a full range of reproductive health services, even as reproductive justice activists celebrated when the United States Supreme Court ruled in *Whole Woman's Health v. Hellerstedt* that Texas could not place restrictions on abortion services delivery that create an undue burden for women seeking abortion. The political climate surrounding women's health remains tumultuous, with anti-abortion measures being introduced through states at an alarming rate.

Women's reproductive healthcare needs are still compromised in the aftermath of the 2014 Supreme Court ruling of *Burwell v. Hobby Lobby*, which favored corporations' religious liberties over women's preventive health needs for contraception under the Affordable Care Act (ACA). Congress's failure to pass funding to combat the Zika virus has deeply affected women in areas such as Louisiana, Florida, and Puerto Rico. These trends continue to impact women with the least power and political capital – women of color, low-income women, and uninsured women.

In 2016, our Reproductive Justice program focused on two strategies to resource, develop, and strengthen state and local organizations as powerful and sustainable leaders for reproductive justice: cross-movement building in Southern states; and leadership capacity and sustainability of reproductive health/reproductive justice organizations.

Over the last year, Ms. Foundation's support to our grantees has continued to help build state-level capacity to mobilize underrepresented constituencies, increase civic engagement through organizing, support ACA implementation and Medicaid expansion, and shift power so as to contribute to longer term, sustainable policy wins for reproductive health, rights, and justice.

Reproductive & Sexual Health, Rights, & Justice

Co-Director: Erin Garner Ford, Visalia, CA

ACT for Women and Girls (ACT) works in California's rural Tulare County, engaging young women in leadership and advocacy to promote reproductive justice activism and social change. Ms. Foundation's grant supports ACT's Female Leadership Academy (FLA) and Central Valley Alliance for Women (CV Alliance), their leadership programs cultivating grassroots activism, and ACT's Pharmacy Access campaign to increase access to emergency contraception.

California Latinas for Reproductive Justice ... \$30,000

Executive Director: Laura Jimenez, Los Angeles, CA

California Latinas for Reproductive Justice (CLRJ), a statewide policy and advocacy organization, advances reproductive health and rights for California's Latina families and communities. Ms. Foundation's grant supports CLRJ's mission to ensure all Latina adolescents and young women have access to culturally appropriate, comprehensive, accurate, and unbiased reproductive rights and sexual health information and services.

Colorado Organization for Latina Opportunity and Reproductive Rights.....\$35,000

Executive Director: Cristina Aguilar, Denver, CO

Colorado Organization for Latina Opportunity and Reproductive Rights (COLOR) promotes and protects reproductive health for Latinas and their families through leadership development, organizing, and advocacy. This portion of Ms. Foundation's grant supports COLOR's continued engagement of the Latina community through advocacy, organizing, and training for reproductive justice, with the goal to move the state in a direction where low-income women can access abortions; contraception is available to all women; and information about family planning is readily available for all families.

Executive Director: Angeline Echeverria, Raleigh, NC

El Pueblo strengthens the Latino community in North Carolina through leadership development, proactive and direct advocacy, education, and promotion of cross-cultural understanding. Ms. Foundation's grant supports Derechos Sin Fronteras, El Pueblo's core, intensive reproductive health and justice training program for Latinx youth leaders that also focus on voter registration and engagement for Latinx populations across the state.

Kentucky Health Justice Network* \$20,000

Board Chair: Caitlin Willenbrink, Louisville, KY

Kentucky Health Justice Network (KHJN) promotes broad-based, inclusive participation in the reproductive justice movement to increase the access, quality, and scope of culturally-relevant and accurate health information and services for low-income women of color and the LGBTQ community. Ms. Foundation's grant supports KHJN's coalition-building activities for reproductive justice; grassroots education and training for women of color, low-income women, and women from rural communities; and continued work on its Trans Health campaign to raise awareness of and education on health barriers among the trans community.

National Asian Pacific American Women's Forum*....\$40,000

Executive Director: Miriam Yeung, Brooklyn, NY

National Asian Pacific American Women's Forum (NAPAWF) advances expanded access to reproductive health for Asian and Pacific Islander (API) women and girls, and political visibility and power as critical components of progressive social change movements. Ms. Foundation's grant supports NAPAWF's continuing efforts to combat sex- and race-selection and abortion bans at the state and federal levels through strategic education and advocacy; build leadership support amongst the API community to engage in reproductive health that meets the needs of API and immigrant women and girls,; and build support for publicly-funded abortion.

National Latina Institute for Reproductive Health*....\$40,000

Executive Director: Jessica González-Rojas, New York, NY

The National Latina Institute for Reproductive Health (NLIRH) works to ensure Latinas' rights to reproductive health and justice through public education, community mobilization, and policy advocacy. Ms. Foundation's grant supports NLIRH in three critical areas: increasing abortion access, eliminating reproductive health disparities, and advancing immigrant women's rights. The grant also supports NLIRH's Latina Advocacy Network (LAN), building and strengthening grassroots advocacy in the Rio Grande Valley.

Native American Women's Health Education Resource Center*\$30,000

Executive Director: Charon Asetoyer, Lake Andes, SD

The Native American Women's Health Education Resource Center (NAWHERC) addresses Native American issues regarding health, education, land and water rights, and economic development issues. Ms. Foundation's grant supports their efforts to train emerging Native women activists in civic engagement and reproductive justice issues in South Dakota, Oklahoma, and New Mexico, in addition to NAWHERC's advocacy for standardized sexual assault policies and protocols, including access to Plan B/emergency contraception.

Planned Parenthood Southeast \$15,000

Director of Public Policy: Felicia Brown-Williams, Atlanta, GA

Planned Parenthood Southeast (PPSE) works in Alabama, Georgia, and Mississippi to ensure quality reproductive health, by providing comprehensive, medically accurate sex education, services, and advocacy. Ms. Foundation's grant supports PPSE's constituency power building efforts; research on innovative ways to serve its population; and listening meetings in Alabama and Mississippi, with a particular focus on women of color and young women.

Reproductive Justice Collective*......\$30,000

Program Director: Charmaine Lang, Milwaukee, WI

Reproductive Justice Collective (RJC) works to increase engagement and leadership among women of color and assists progressive organizations, policymakers

and institutions with policy, service, and constraints analysis that disproportionately affect these women. Ms. Foundation's grant supports RJC's continued goal to address reproductive justice issues for low-income women of color and families, through increased political participation, organizing, community outreach, and civic engagement...

SisterReach*.....\$30,000

CEO: Cherisse Scott, Memphis, TN

SisterReach supports the reproductive autonomy of women and girls of color, poor women, rural women and their families. Ms. Foundation's grant supports SisterReach's institutional growth and sustainability of grassroots organizing work that empowers women and girls in the Memphis community around their reproductive and sexual health.

SisterSong*.....\$30,000

Executive Director: Monica Simpson, Atlanta, GA

SisterSong is a national organization that unites and strengthens the voices of women of color and indigenous women to dismantle reproductive and racial oppression. Ms. Foundation's grant supports their regional and national networking work, such as the Southern Reproductive Justice Policy Initiative, Artists United for RJ, the Trust Black Women campaign, and their cross-movement building with the Fight for \$15 and Black Lives Matter movements.

SPARK Reproductive Justice NOW \$25,000

Executive Director: Dr. Krystal Redman, Atlanta, GA

SPARK Reproductive Justice NOW (SPARK) builds and sustains a powerful reproductive justice movement in Georgia by organizing and building the leadership capacity of African-Americans, Millennials, LGBTQ youth, and young families of color communities.

Ms. Foundation's grant supports SPARK's fight for equitable abortion access through advocacy, leadership development, and civic engagement. In particular, this grant supports SPARK'S two leadership development programs, the Speak Justice Take Action (SJTA) initiative and Fierce Youth Reclaiming & Empowerment (FYRE), along with the Healthy Access resource guide to increase understanding of the ACA's impact in Georgia.

URGE (Unite for Reproductive and Gender Equity)\$45,000

Executive Director: Kierra Johnson, Washington, DC

URGE (Unite for Reproductive and Gender Equity), a national organization, supports emerging young leaders through training, organizing, networking, and idea exchanges. Ms. Foundation's grant supports URGE's work building a national base of reproductive advocates through strategic state chapters (KS, OH, TX, GA, and FL), and framing and influencing national policy dialogues around reproductive justice, abortion rights, and access.

WV FREE \$35,000

Executive Director: Margaret Chapman Pomponio, Charleston WV

WV FREE works for women and families to improve education on reproductive options and rights. Ms. Foundation's grant supports WV FREE's continued efforts to defend reproductive decisions, increase access to affordable birth control, and educate the public, policymakers, and health providers about reproductive justice policies that help decrease poverty levels and rates of unintended pregnancies.

Young Women United \$35,000

Executive Director: Tannia Esparza, Albuquerque, NM

Young Women United (YWU) focuses on improving young people's access to comprehensive sexuality education, information, and services in Albuquerque public schools. The Ms. Foundation for Women has prioritized the safety of women and girls since our founding, and supported organizations that work to end all forms of gender-based violence.

After six years, we concluded our investment in child sexual abuse prevention and pivoted our focus to redefine the Safety movement through a Black, queer, feminist lens. To this end, Ms. Foundation's Safety program is building a cohort of local, regional, and national organizations working to address the effects of criminalization, sexual violence, and state-sanctioned violence on the lives of Black women and girls. Safety prioritizes work that advances a proactive agenda for long-term systemic changes in the political and public spheres, where the safety of all people is envisioned through a lens that centers on those most historically underrepresented in social justice movements, including trans women.

The Ms. Foundation selected the inaugural cohort of seven Safety grantee-partners in June 2016. In this first phase of grantmaking, our focus is on organizations led by Black women and girls that utilize organizing, advocacy, policy, and healing justice to dismantle systems that harm them, and us all. As the work of the cohort evolves, the Safety program will elevate and support policy platforms and advocacy campaigns, coalition-building, public education campaigns, as well as strategies to identify unlikely allies and new communities.



Redefining Safety through a Black, Queer, Feminist Lens

Black Women's Blueprint\$25,000

Commitment to Change: Isabel Allende

What do you feel are the greatest challenges facing women and girls today?

Women's rights took a significant step backward after the [U.S.] election. Many issues which were moving in a forward direction, such as reproductive freedom, a curtailing of sexist speech, access to healthcare, and equal pay, are now in the crosshairs again.

I have lived through historic moments like this one before and know that change will come very quickly. But we cannot give up or speak in terms of defeat. We have to keep fighting for what we believe in and speaking in terms of hope.

The Isabel Allende Foundation is going to redouble its efforts in three areas: reproductive rights, freedom from violence, and economic empowerment for all women.



We believe that three types of work must be supported in order to achieve widespread and lasting impact. These include: grassroots and local efforts to provide direct services; organizations educating the public about these issues; and those working to effect policy and legislative change (through judicial and other means). In our grant making, we have been persuaded that all three are necessary to address the immediate and long-term issues impeding women's equality and power.

You've been a donor to the Ms. Foundation for Women since 1991, which is a remarkable legacy of sustaining support. What attracted you to MFW?

I was a feminist in Chile before there was even a word for feminism. When I created my foundation, I knew I wanted to help women working towards a vision of a world in which women have achieved social, economic and political equality. So the mission of my foundation and that of the Ms. Foundation are very similar. Of course, I also love Gloria and am proud to support work she supports.

Chilean author Isabel Allende won worldwide acclaim when her bestselling first novel, The House of the Spirits, was published in 1982. She has since written 20 more works which have sold more than 67 million copies, all written in her native Spanish and translated into more than 35 other languages. Allende made her first gift to the Ms. Foundation for Women in 1991. She describes her fiction as rooted in her remarkable upbringing, and the mystical people and events that fueled her imagination. Her writings are equally informed by her feminist convictions, her commitment to social justice, and the harsh political realities that shaped her destiny.

Ending The Sexual Abuse To Prison Pipeline For Girls

Young women who are victims of sexual abuse and violence are at higher risk of landing in the juvenile justice system, especially if they are girls of color, from low-income backgrounds, or identify as LGBTQ. **The Sexual Abuse to Prison Pipeline:The Girls' Story,** released July 2015, critically analyzes continued traumatization and criminalization of girls victimized by abuse, and how they wind up in a system ill-equipped to address the trauma they face to provide help they truly need. "Sexual Abuse to Prison Pipeline" represents the partnership of the Ms. Foundation for Women, the Human Rights Project for Girls, and the Center on Poverty and Inequality at Georgetown University to highlight the experiences of girls in the juvenile justice system.

In addition to receiving support from Parsons, Raising Women's Voices worked with the Ms. Foundation's external affairs team to produce **My Health, My Voice: A Woman's Step-By-Step**

Convenings For Economic Justice And Women's Health

Each year the Ms. Foundation hosts convenings to bring our grantee-partners together to receive indepth trainings, engage in presentations and focused discussions, and have the chance to foster partnerships and networks with other grassroots activists committed to improving the lives of women and their communities and families. Our **Women's Health** grantee-partners met in September 2015 and May 2016, while our **Economic Justice** grantees met in March 2016, where they brainstormed and strategized on strengthening and expanding the movement for gender equality and social justice.

Tackling Garment Workers' Need For Quality Child Care

Ms. Foundation grantee-partner Garment Worker Center fights against labor abuses, for worker safety, and for services that improve the lives of low-income garment workers in Los Angeles. In 2015 the GWC released

#MyFeminismIs: Broadening Conversations On Feminism

In October 2015 the Ms. Foundation for Women launched **#MyFeminismIs**, a thought-provoking campaign about feminism, inclusion, and intersectionality. The campaign followed up on the Listening Tour and Ms. Foundation's national survey about women's issues and feminism (August 2015); and featured more than 42 interviews with activists, advocates, philanthropic leaders, and organizers, including Cecile Richards from Planned Parenthood, former NFL football player and LGBT advocate Wade Davis, TV host Melissa Harris-Perry, and comic and "Daily Show" co-creator Lizz Winstead. #MyFeminismIs generated over 12,500 tweets and 135 million views, expanding the conversation to include more voices and ideas about the belief in the social, economic, and political equality of all genders.

Raising Women's Voices: My Health, My Voice

More than seven million women enrolled for healthcare under the Affordable Care Act (ACA) in 2015. Along with more women having healthcare, there were more women in need of answers and assurances to their questions and concerns about having coverage. That led to Ms. Foundation grantee-partner Raising Women's Voices (RWV) creating **My Health, My Voice: A Women's Step-by-Step Guide to Using Health Insurance** with an accompanying journal. White House Summit On Women And Girls: Committing To Women's Economic Security



In November 2015 the Ms. Foundation for Women joined current and former granteepartners, activists,

academics, government and private sector experts, and policymakers for the revolutionary **White House Summit on Women and Girls**, with a focus on advancing equity for women and girls of color. As a way to emphasize the importance and commitment to ensuring that every woman and girl has the opportunities and chance to improve her life, the Ms. Foundation also announced our partnership in **Prosperity Together**, a nonpartisan coalition of public women's foundations committing a \$100 million investment in programs and policies to support women and girls of color.

Public Voices Fellowship

In February 2016 the Ms. Foundation, in partnership with the OpEd Project, launched the **Public Voices Fellowship** aimed at diversifying the voices and



quality of ideas about women's economic security, reproductive justice, and women's safety in mainstream media. Nineteen grantee-partners joined the Fellowship, receiving intensive training through workshops and presentations, as well as resources and access to speak up and out about the issues they work every day to advance. The fellowship, as part of the highly-successful pilot initiative by OpEd Project and partners from the country's leading universities and foundations, promoted conversations on gender in America from the viewpoints of representatives from marginalized communities. Seventy op-eds produced by the Fellows have appeared in news outlets such as *Huffington Post, Time, and Ebony*.


Fighting For Reproductive Health Access And Choice

As states continued to introduce legislation opposing a woman's right to make her own healthcare decisions, the Ms. Foundation and our grantee-partners



continued to fight for reproductive choice and access. In March 2016 we joined grantee-partners on the U.S. Supreme Court steps to rally during arguments for Whole Woman's Health v. Hellerstedt. Whole Woman's Health challenged abortion restrictions in Texas that have decimated the number of clinics performing abortions in the state. In June, we all celebrated the tireless efforts of our partners, such as the National Latina Institute for Reproductive Health and their public education campaign about the harm such restrictive laws would have on women of color and immigrant communities, when the Supreme Court struck down those restrictions.



Native Girls, released in 2016 and produced through the Ms. Foundation's Parsons Project, addresses tragic statistics: Native American women experience sexual assault at a rate 2.5 times higher than any other race or ethnicity in this country; and few resources are available to victims of sexual assault living on tribal lands. NAWHERC has long fought for access to Plan B/emergency contraception for tribal communities, and finally achieved a victory when the Indian Affairs Bureau (the federal agency managing Native American territories) granted access in late 2015.

In May 2016 Ms. Foundation grantee-partner Young Women United (YWU) released **Dismantling Teen Pregnancy Prevention**,

a report focusing on dispelling myths about teen pregnancy, replacing them with fact-based programs and services – and greater understanding of the systems of

inequity - to help young parents and their children. YWU, as a champion of reproductive healthcare and justice for young women in New Mexico, offers a report that reflects their continued advocacy against stigmatizing women's reproductive healthcare decisions.

United State Of Women Summit

In June 2016 the Ms. Foundation, current and former grantee-partners, and other organizational partners headed to Washington, DC for the **United State of Women Summit (USOW).** The summit focused on six pillars to address gender inequity: economic empowerment; health and reproductive justice; access to education; support for survivors of gender-based violence; human rights; and civic engagement, leadership and community organizing. The USOW summit also featured keynote speeches from both President Barack Obama and Vice-President Joe Biden, and charged organizations and individuals to act more in support of gender equality.




